In view of the above submission, nothing further survives for consideration in these writ petitions, which are accordingly disposed of. No costs.

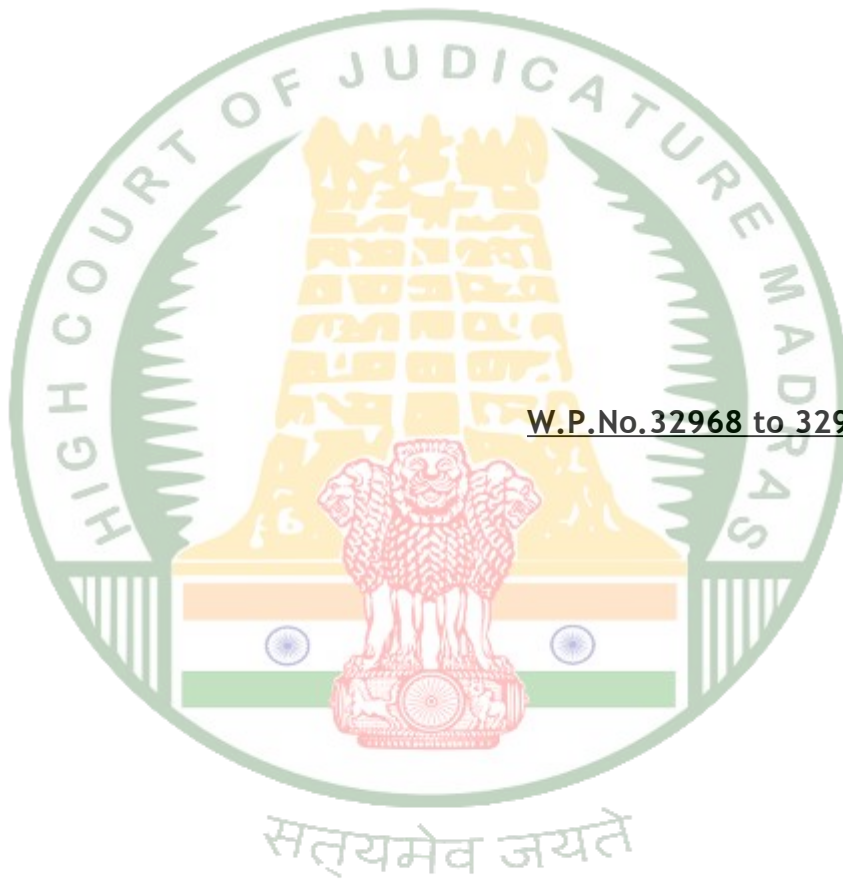
