ORDER

2.The issue involved in this writ petition has already been covered by a judgment rendered by this Court in W.P.No.33984 of 2016 dated 04.10.2016, wherein it was held as follows:

"42.....

(viii) The State Government and State Election Commission shall look into and decide about complaints regarding reservation, dereservation of posts, deletion or addition of genuine eligible voters and enrolment of bogus voters, etc., before conducting the election, after issuance of fresh election notifications."

3.In such view of the matter, the petitioner is directed to work out his remedy accordingly. It is needless to state that the authorities concerned will look into the request of the petitioner, if permissible by law.

4.With the above direction, the writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.

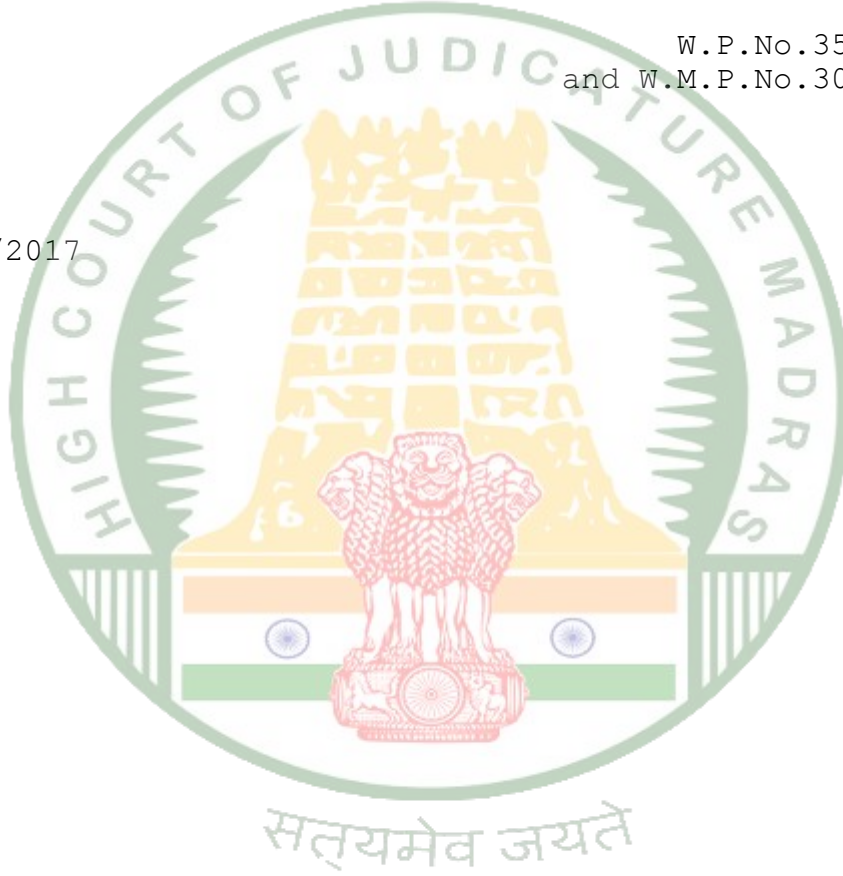
