Prayer : Writ Petition is filed under Article 226 of the Constitution of India for issuance of a Writ of Mandamus, directing the respondents to consider the representation of the petitioner dated 24.06.2016 in accordance with law and on merits taking into consideration the service of the petitioner, the fact that the juniors to the petitioner were included in the Kalith Commission Report, and to include the petitioner in Old Pension Scheme to meet the ends of Justice, award costs.

5.In this view of the matter the third respondent is directed to consider the representation submitted by the writ petitioner on 24.06.2016 and pass orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

6.Accordingly, the writ petition stands disposed of. However, there is no order as to costs.
