Considering the limited prayer made by the petitioner, without expressing any opinion on the merits of the case, the first respondent is hereby directed to consider the representation dated 06.09.2016 and pass appropriate orders on merits and in accordance with law, within a period of three months from the date of receipt of a copy of this order.

6. With the above direction, the writ petition is disposed of. No costs. Consequently, connected M.P. is closed.
