Prayer in W.P.No.23791 of 2004: The writ petition filed under Article 226 of the Constitution of India, to issue a writ of Certiorarified Mandamus calling for the records pertaining to the notice dated 15.07.2004 of the respondent herein and quash the same and consequently forbear the respondent from interfering with peaceful possession and enjoyment of the property in Oor Natham bearing S.No.832 and with the superstructure in Door No.3/237 of Pudukkottai, Rajan Nagar Village, Sathyamangalam Taluk, Erode District, measuring 624 sq. ft. i.e. 1 ½ cents East West 22 ¼ and North South 28 feet, belonging to the writ petitioner.
