The writ petition has been filed by the petitioner seeking for issuance of a writ of Certiorarified Mandamus, to call for the records relating to the order of the second respondent issued in Na.Ka.No.103952/W2/W29/03, dated 22.04.2004, quash the

same and consequently direct the respondents 1 to 3 herein to contiously pay salary and other benefits as P.G Assistant Economics from September 2003.

3. During the pendency of this writ petition, interim order was passed by this Court on 02.06.2004.
