Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of certiorari, calling for the records relating to the impugned bill dated 01.09.2003 in respect of HTSC No.137 on the file of the 2nd respondent and quash the same insofar as the claim for a sum of Rs.1,02,009/- levied in excess towards the demand charges.

ORDER

Heard the learned counsel on either side and perused the material documents available on record.

Today, when the matter is taken up for hearing, learned counsel for the petitioner submitted that for consumption of electricity for 13 days electricity, a sum of Rs.7,93,588/- has been demanded by the respondent/Electricity Board. However, it is submitted by the learned counsel that the petitioner has paid

the entire amount demanded by the respondent/Electricity Board and nothing further survives for consideration in this matter.

3. Recording the submission of the learned counsel for the petitioner, this Writ Petition is dismissed as having become infructuous. It is made clear that if any amount is due to be paid by the petitioner to the respondent/Electricity Board, it is open to the respondents to demand the same from the petitioner, in accordance with law. No costs. Consequently, connected W.P.M.P.No.31531 of 2003 is closed.
