Thiruvannamalai in R.No.2674/A3/99, dated 1.3.1999 rejecting the application for variation of condition of permit involving revision of timings with the grant of two additional singles of their bus TN 23/X-5009 since replaced by TN-23/V-2576 plying on the route Arni to Chennai and quash the same.

Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorari calling for the records relating to the judgment of the State Transport Appellate Tribunal, Chennai in Appeal No.226 of 1994, dated 12.5.2004 dismissing the appeal confirming the order of the R.T.A. Thiruvannamalai in R.No.1850/A3/99, dated 1.3.1999 rejecting the application for variation of condition of permit involving revision of timings with the grant of two additional singles and change of night halt of their bus in TN 23/X 5004 since replaced by TN 23/V 2552 plying on the route Arni to Chennai and quash the same.
