Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of certiorarified mandamus, calling for the records of the respondents relating to the impugned order of assessment made by the 3rd respondent in No.86/Udumalpet/Ward-B/Block-8/Fasli-1401, dated the 11th January 1994, which was confirmed by the order of the 2nd respondent in U.L.T.A.108/98-E5, dated 8th April 2000, and again confirmed by the order of the 1st respondent in the Revision Petition No.Rc.12889/2000-D2, dated the 5th May 2003, quash the same and as a consequential or further relief, directing the respondents to refund to the petitioner the total sum of Rs.12,960/- with interest at 18% per annum, which has been collected from the petitioner by the 4th respondent till today, towards Urban Land Tax.
