Prayer in W.P.No.17474 of 2004:

Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus to quash the order bearing Ref.No.Ta.Aa.Po.Ka./ D 8/ Ve/ 164/ 03 dated 17.06.2003 passed by the 2nd respondent as arbitrary, illegal and contrary to clause 11 of the certified Standing Orders and consequently direct the respondents to

grant the petitioner medical leave for 14 days and to reimburse the fine of Rs.100 which was imposed by the 2nd respondent.

Prayer in W.P.No.17475 of 2004:

Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus to quash the order bearing Ref.No.Ta.Aa.Po.Ka./ Oa.Na./D8/Ve/ 196/ 03 dated 04.01.2004 passed by the 2nd respondent as arbitrary, illegal and contrary to clause 11 of the certified Standing Orders and consequently direct the respondents to grant the petitioner medical leave for 15 days and to reimburse the fine of Rs.100 which was imposed by the 2nd respondent.

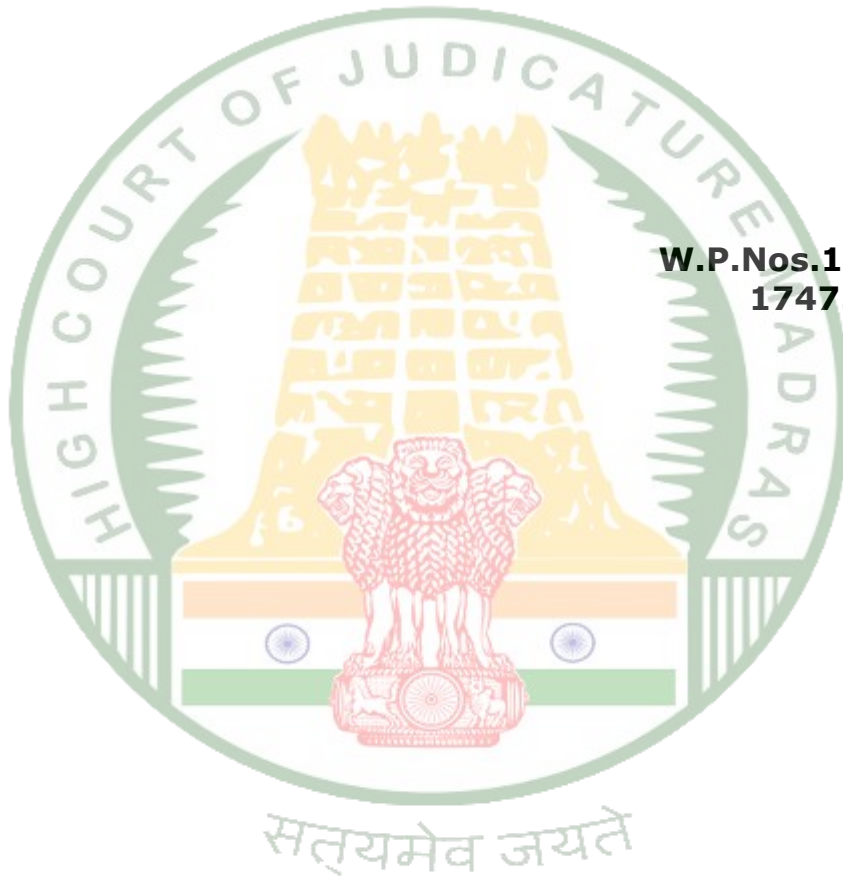
