4. Recording the submissions made by the learned counsel on either side, the writ petition stands closed. No costs. Consequently, connected miscellaneous petition is also closed.

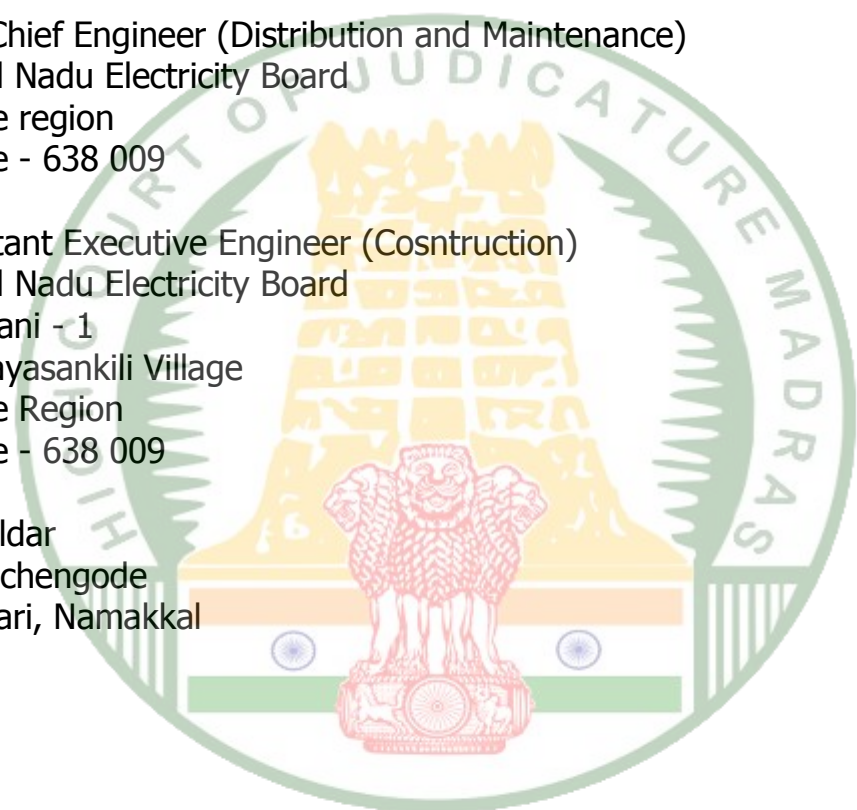
