PRAYER: Writ Petition filed under Article 226 of Constitution of India, to issue a Writ of Certiorarified Mandamus to call for the records on the file of the third respondent pertaining to clause 15(ii) of the M.B.B.S./B.D.S. Admissions prospectus 2004-2005 and quash the same insofar as it restricts the reservation seats in M.B.B.S. and B.D.S. Courses to children of ex-servicemen only to the exclusion of children of Serving defence personnel and consequently direct the respondents to reserve two seats in M.B.B.S. and B.D.S. Courses for children of serving defence personnel in Government Medical College.
