2.that the appellant/Insurance Company be and hereby is directed to deposit the entire award amount to the credit of M.C.O.P.No.107 of 2010, on the file of Motor Accidents Claims Tribunal - cum - Chief Judicial Magistrate, Tirunelveli, less the

amount already deposited, if any, along with interest at the rate of 7.5% per annum from the date of petition till date of realisation and proportionate costs within a period of six weeks from the date of receipt of a copy of this judgment.

3.that on such deposit, the Tribunal be and hereby is directed to transfer the award amount to the personal savings Bank Account Number of the Claimant, after getting their Account details, within a period of two weeks thereafter.

4.that there be no order as to cost.
