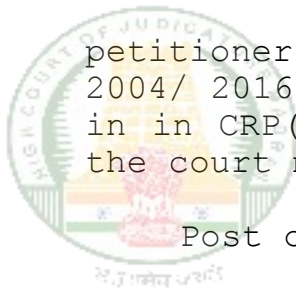
Prayer in CMP(MD). 8644/ 2017 in CRP(MD). 1551/ 2017 :
