Prayer in CMA(MD)No.89 of 2016:

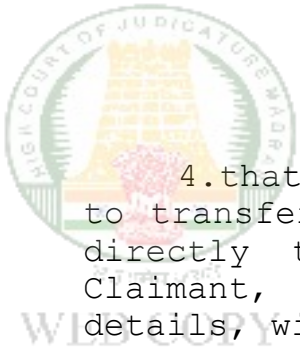
Appeal filed under Section 173 of the Motor Vehicles Act, 1988, against the order and decretal order dated 10.08.2015 made in MCOP No.257/2013 on the file of the Motor Accident Claims Tribunal/Special District Court, Tiruchirappalli.

DECREE: This Appeal coming on for hearing on this day, upon perusing the Grounds of Appeal, the order and decretal order of the Lower Court and the material papers in the Appeal and upon hearing the arguments of Mr.P.Prabhakaran, Advocate for the Appellant and of Mr.H.Arumugam, Advocate for the sole Respondent this Court while dismissing this Appeal, doth order and decree as follows:

1. that the order and decretal order dated 10.08.2015 made in MCOP No.257/2013 on the file of the Motor Accident Claims Tribunal-cum-Special District Court, Tiruchirappalli be and hereby are confirmed, and the Civil Miscellaneous Appeal is dismissed;

2. That the Claimant be and hereby is directed to submit her Savings Bank Account details along with the copy of her passbook to the tribunal forthwith;

3. that the appellant-Transport Corporation be and hereby is directed to deposit the entire award amount along with accrued interest and costs, less the amount already deposited, if any, to the credit of MCOP No.257 of 2013 before the Motor Accident Claims Tribunal-cum-Special District Court, Tiruchirappalli, within a period of eight weeks from the date of receipt of a copy of the Judgment;



4.that on such deposit, the tribunal be and hereby is directed to transfer the award amount along with accrued interest and costs directly to the Personal Savings Bank Account number of the Claimant, through RTGS/NEFT system, after getting her Account details, within a period of two weeks thereafter;and

5.that there be no costs in this Civil Miscellaneous Appeal.
