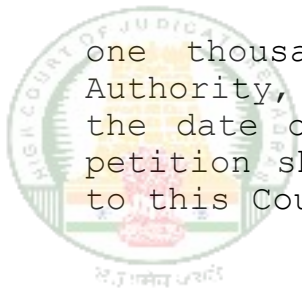
PRAYER IN CRP(MD) No.SR5307 of 2016:-
