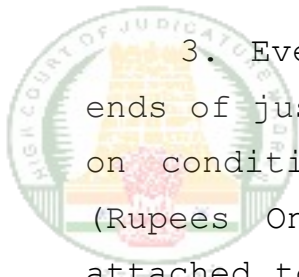
PRAYER IN CRP(MD)SR19399/2017 :
