2. Heard the learned Counsel for the petitioner.

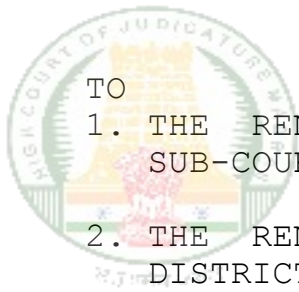
