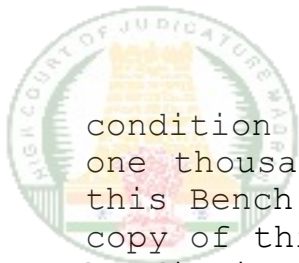
PRAYER IN CRP(MD) No.SR23455 of 2017:
