WP(MD)No.2180 of 2011:-

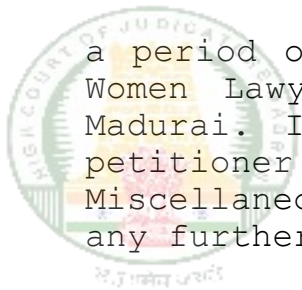
