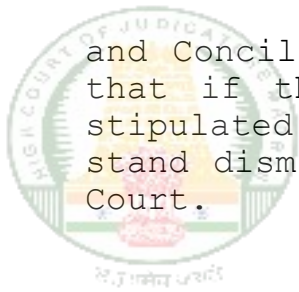
PRAYER IN CMA(MD) No.SR 14025 of 2013
