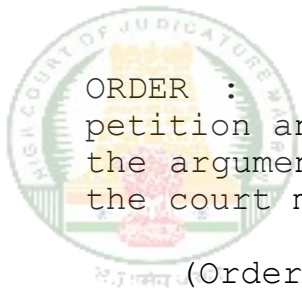

Prayer in WP(MD). 18123/ 2014 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the Respondents to confer permanent status to the Petitioners from the date of completion of 480 days of their joining in the service of the 3rd Respondent and consequently direct the Respondents to grant the service benefits of promotion, back wages, continuity of service, family pension benefits and all other concomitant service benefits eligible to the petitioners.
