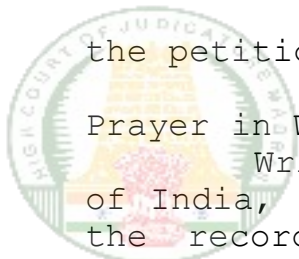

Prayer in WP(MD). 10407/ 2008 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certioraraified Mandamus, call for the records from the 1st respondent in Go (3D). No. 329 Agriculture (AA7) Department dated 26/10/2007 quash the same and direct the respondents to return the sum of Rs. 3,600/- which was deducted from the pension of the petitioner as punishment and Rs. 2,31,606/- whi9ch was deducted from the retirement benefits of



the petitioner to the petitioner.

Writ Petition is filed under Article 226 of the Constitution of India, for issue of writ of Certiorarified Mandamus, to call for the records from the 1st respondent in GO (3d) No.311 (AA7) Department dated 17.10.2007 and direct the 1st Respondent to grant suitable promotion to the petitioner as Deputy Director of Agriculture with all financial benefits.
