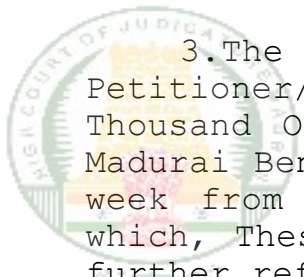
Prayer in CMP(MD) . 3843/ 2017 :
