ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.J.LAWRANCE, Advocate for the petitioner the court made the following order:-

Heard the learned counsel appearing for the petitioner.

2. There is a delay of 356 days in representing the papers. Though the petitioner has explained the reasons for the delay in the affidavit filed in support of the petition, since the delay is on higher side, the same can be condoned on payment of costs. Accordingly, the delay of 356 days in representing the papers is condoned on condition the petitioner paying a sum of Rs.750/- (Rupees Seven Hundred and Fifty Only) to the "The Bubbles' Day Care Creche" maintained by the Woman Advocate Association, attached to the Madurai Bench Madras High Court, Madurai, within a period of two weeks from the date of receipt of a copy of this order, failing which, this petition shall stand dismissed automatically without further reference to this Court.



3. Accordingly, this petition is ordered.
