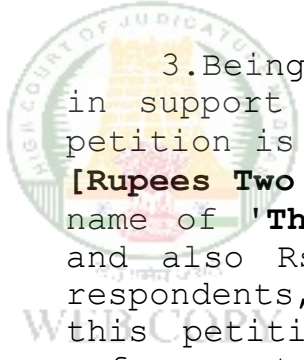
PRAYER IN S.A(MD) No SR4537 of 2011:
