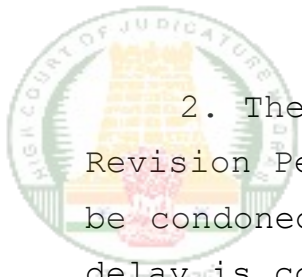

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.M.S.JAWAHARLAL, Advocate for the petitioner and of MR.S.P.MAHARAJAN, Advocate for R1 the court made the following order:-



2. There is an inordinate delay of 173 days in filing the Civil Revision Petition and therefore, this Court feels that the delay can be condoned on payment of costs to the Legal Aid. Accordingly, the delay is condoned and this petition is ordered on condition that the petitioner shall deposit a sum of Rs.1,000/- (Rupees one thousand only) to the Legal Aid Service Authority, attached to this Bench, within a period of one week from the date of receipt of a copy of this order, failing which, this petition shall automatically be dismissed without further reference to this Court.
