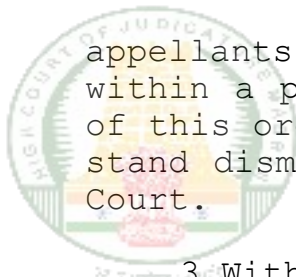
Prayer in CMP(MD). 6244/ 2017 in AS(MD) No.107 of 2017 :
