Prayer in M.P(MD).No.1 of 2013:-

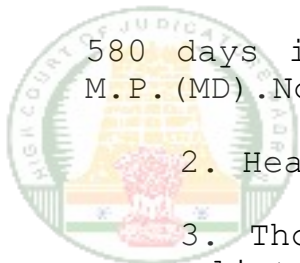
