dismissed for Non prosecution on 13.4.2016.

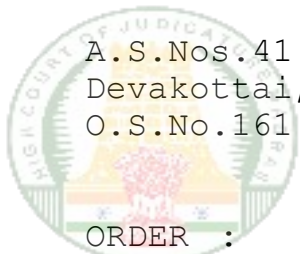
Prayer in Rev.Aplc(MD) No.132 of 2015:-
