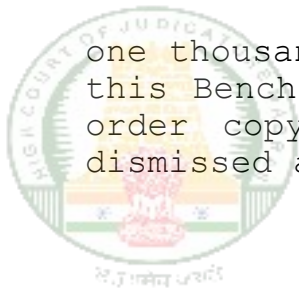
Prayer in CMA(MD) No.SR49549 of 2016 :
