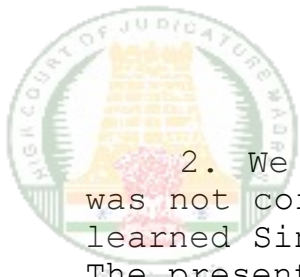
**PRAYER IN WP(MD)No. 362 of 2017:**
