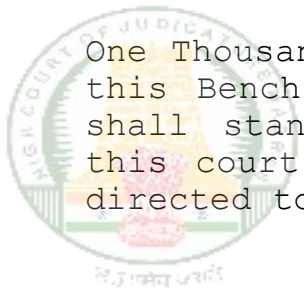
PRAYER IN CMA(MD) No.SR21509 of 2016
