Accordingly, the delay is condoned and this petition is ordered on condition that the petitioner shall deposit a sum of Rs.500/- (Rupees Five hundred Only) to the Legal Aid Service Authority, attached to this Bench, within a period of one week from the date of receipt of a copy of this order, failing which, this petition shall automatically be dismissed without further reference to this Court.



3. On producing the receipt for payment of costs, the Registry is directed to list the matter for admission on 03.11.2017, if it is other wise in order.
