ORDER:

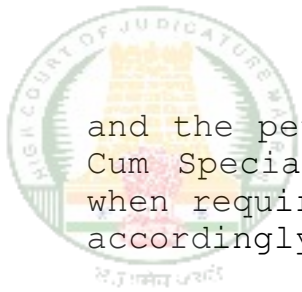
