2. Heard the learned Counsel appearing for the petitioners.

3. The learned Government Advocate (Crl.side) submitted that the petitioners are complying with the condition regularly for a period of sixteen weeks.

4. Considering the facts and circumstances of the case, the condition already imposed on the petitioners are relaxed and the petitioners shall appear before the respondent police, as and when required for interrogation on receipt of summons. This petition is ordered.
