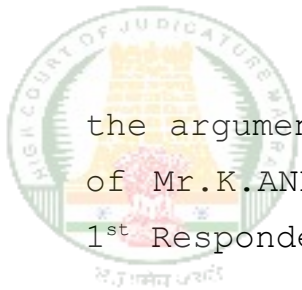
Prayer in CRL MP(MD) No.10339 of 2017:
