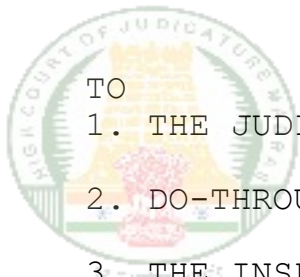
2.Heard the learned Counsel appearing for the petitioner.
