The Petitioner filed this modification petition to produce surety before the learned Judicial Magistrate, Kulithurai, Kanyakumari District to any other Magistrate Court, Tirunelveli District in Crl.O.P.(MD)No.14667 of 2017 dated 31.10.2017.

2.Heard the learned counsel for the petitioner.

3.The Learned Government Advocate (Crl. Side) appearing for the respondent Police submitted that the petitioner initially accepted to produce two sureties before the learned Judicial Magistrate, Kuzhithurai, Kanyakumari District in order to get anticipatory bail before this Court. Accordingly, as per the request of the learned counsel for the petitioner, the said condition was imposed.

4.Considering the facts and circumstances of the case and also considering the learned Government Advocate (Crl.side), there is no valid reason to modify the order passed by this Court in Crl.O.P.
