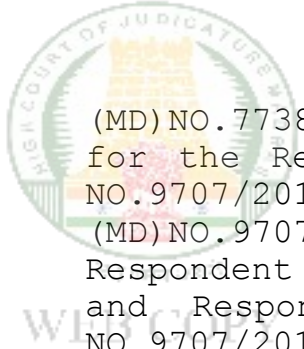
Prayer in CRL MP(MD).10689/ 2017 IN CRL OP(MD)NO.9707/2017 :
