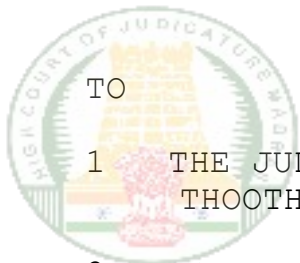
2.Heard the learned counsel appearing for the petitioner.
