The Petitioner filed this petition for relaxing the condition imposed by this Court for the offences punishable under Sections 21 (1) of Mines and Mineral Regulation Act 1957 and Section 379 I.P.C., in Crime No.593 of 2017 while granting anticipatory bail.

2.Heard the learned Counsel appearing for the petitioner.

3.The learned Government Advocate (Crl.side) submitted that the petitioner is complying with the condition before the respondent police regularly.



4.Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Crl.side), the condition already imposed on the petitioner is modified to the effect that the petitioner shall appear before the respondent police once in a week i.e., on every Monday at 10.30 a.m until further orders.
