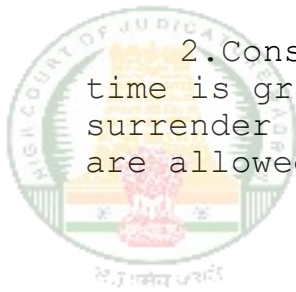
Prayer in CRL MP(MD) No.1299 of 2017
