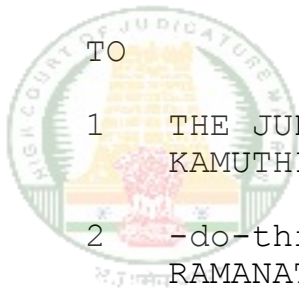
3.Considering the facts and circumstances of the case, the earlier condition is relaxed. This petition is ordered accordingly.
