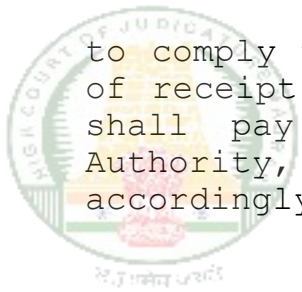

2.This Court by order dated 05.01.2017 granted anticipatory bail to the petitioners, directing them to appear before the concerned Court within a period of 15 days from the date of receipt of a copy of this order. The order copy was made ready only on 20.01.2017 and the present petition is filed before this Court on 15.02.2017 and hence, there is a delay of 10 days.

3.Considering the facts and circumstances of the case and being satisfied with the reasons stated in the affidavit, the time



to comply with the conditions is extended by 10 days from the date of receipt of copy of this order on condition that the petitioners shall pay a sum of Rs.300/- to the District Legal Services Authority, Nagercoil at Kanyakumari. This petition is ordered accordingly.
