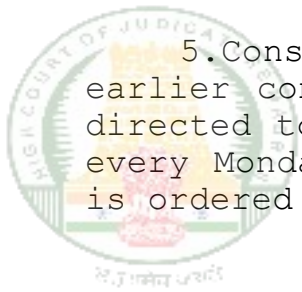

The learned counsel for the petitioner is present.

This Court by order dated 10.02.2017 in Crl.O.P.(MD)No.1440 of 2017 directed the petitioner to appear before the Kumbakonam Taluk Police Station, Kumbakonam daily at 10.30 a.m. for a period of two weeks and thereafter as and when required for interrogation. However, the petitioner failed to comply with the said condition and filed the present petition for modification of the said condition, directing the petitioner to appear before the North Police Station, Karaikudi instead of Kumbakonam Taluk Police Station, Kumbakonam.

3.The learned Government Advocate (Crl.side) submitted the final report was filed in C.C.No.36 of 2017 before the Judicial Magistrate No.II, Kumbakonam.

4.The learned counsel for the petitioner submitted that the said case is posted for hearing on 05.04.2017.
