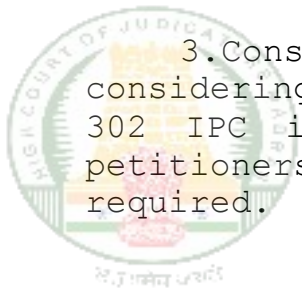
Prayer in CRL MP (MD) . 1743/ 2017 IN CRL OP (MD) NO.179/2017:
