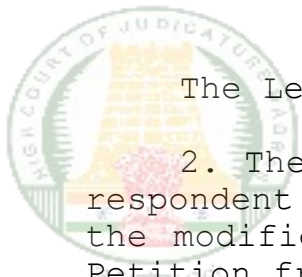
Prayer in CRL MP(MD) . 1748/ 2017 :
