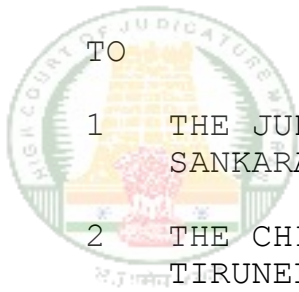
3. The learned counsel for the petitioners states that the petitioners are complying with the condition from 15.02.2017 onwards.
