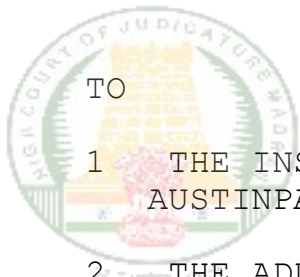
Learned counsel for the petitioner and the learned Government Advocate (Criminal Side) for the respondent are present and heard.
